THE OUTREACH DEPARTMENT TRAINED OVER 8000 PEOPLE ABOUT VISION LOSS. VISIONS RECEIVED 1756 NEW REFERRALS THAT RECEIVED AT LEAST ONE CONTACT. OUTREACH AND SERVICES ARE PROVIDED IN 10 LANGUAGES USING PART TIME INTERPRETERS AND 41 BI-LINGUAL STAFF. 78 BLIND YOUTH AND ADULTS SUCCESSFULLY COMPLETED A PAID INTERNSHIP AFTER-SCHOOL AND DURING THE SUMMER. 43 BLIND YOUTH ATTENDED ONE MONTH RESIDENTIAL PRE-COLLEGE PROGRAMS AT MANHATTANVILLE AND QUEENS COLLEGE. BLINDLINE RECEIVED APPROXIMATELY 1000 INQUIRIES. VISIONS WAS #1 IN JOB PLACEMENT WITHIN NYS FOR A 2ND YEAR.

SESSIONS HELD AT VCB PREPARE BLIND YOUTH AND ADULTS FOR THE WORLD OF WORK AND LEAD TO SUCCESSFUL JOB READINESS. REHABILITATION AND WORK READINESS PROGRAMS THROUGHOUT THE YEAR HELD AT VCB CONTINUE TO SHOW GROWTH FOR ALL AGES. A FOCUS ON HEALTH, WELLNESS, PHYSICAL ACTIVITY AND SOCIAL CONNECTIONS INCREASED THE IMPACT OF VCB SERVICES AS MEASURED BY SELF-REPORTING OF PARTICIPANTS ON SURVEYS. THERE HAS BEEN AN INCREASE IN THE TYPE OF CLASSES OFFERED FOR ADULTS AND SENIORS INCLUDING NEW SUPPORT GROUPS AND NEW EVIDENCE BASED EXERCISE PROGRAMS. THERE WAS AN INCREASE TO 1090 PARTICIPANTS REGISTERED FOR SERVICES AT VISIONS AT SELIS MANOR INCLUDING OVER 700 REGISTERED FOR THE SENIOR CENTER. BASED ON SELF-REPORTED SURVEYS, NEARLY 3/4 OF PARTICIPANTS ARE MORE SATISFIED WITH THEIR LIFE BECAUSE OF PARTICIPATION AT VISIONS; MORE THAN 70% HAVE MADE EXERCISE A PART OF THEIR ROUTINE; MOST REPORT THEY ARE MORE OPTIMISTIC, SELF-CONFIDENT AND CAPABLE OF SELF-ACCEPTANCE.
