OUTREACH AND SERVICES ARE PROVIDED IN 16 LANGUAGES USING PART TIME INTERPRETERS AND 41 BI-LINGUAL STAFF. 78 BLIND YOUTH AND ADULTS SUCCESSFULLY COMPLETED A PAID INTERNSHIP AFTER-SCHOOL AND DURING THE SUMMER. 43 BLIND YOUTH ATTENDED A ONE MONTH RESIDENTIAL PRE-COLLEGE PROGRAMS AT MANHATTANVILLE AND QUEENS COLLEGE. BLINDLINE RECEIVED APPROXIMATELY 1000 INQUIRIES. VISIONS WAS #1 IN JOB PLACEMENT WITHIN NYS FOR A 4TH YEAR.
